4. Details of our assessment

Parc Stormy Annual Returns

The emissions to air and annual performance report were received by NRW on the 31st January 2021.

Emissions to Air

The emissions to air from the CHP'S (A1 and A2) were within the permitted limits and are compliant. However, the NOx emissions are close to the permitted limit of 500 mg/m³ for emission point A1.

Action. The site to send the maintenance schedule for the two CHP planned for 2022 and to explain the high NOx emission of A1. Site to send the details and report of the 40000hr service that was carried out for each engine.

Performance Review

The site has seen a decrease in biogas produced and energy produced. The 40000hr service for both the CHP's resulted in more power being drawn from the grid and less exported. Water sourced from the site borehole increased from 3885 to 4421 m³/year and resulted in a significant reduction in the amount of water imported from the mains. Borehole water has been used for biofilter scrubber, pressure washing of delivery waste vehicles. Also used for washing the reception building floor and general GHK of site.

Nm-VOCs

The site is required by the permit to report Non-methane Volatile Organic Compounds (nm-VOCs). This parameter was not reported in the Air 1 reporting form for 2021.

Nm-VOCs are not routinely monitored anymore due to the absence of a suitable reference method. The reasoning for not monitoring for nm-VOCs anymore is detailed in the Guidance for monitoring landfill gas engine emissions (LFTGN08 vs 2010). LFTGN08 concludes that "*the review of nm-VOCs emissions testing has shown that the previous limits for nm-VOCs were not exceeded. Coupled with the change in monitoring methodology we have removed the nm-VOC emission limit*".

The sites historic emissions for nm-VOCs have all been compliant and well below the permitted level.

The site is not required to submit emission monitoring data for nm-VOCs for future emissions reports for emission points A1 and A2.
