### Hendy Recycling Site Visit – Tarmac Trading Limited, (EPR/ FB3633RD) – 29/01/2019

Environment officer Claudia Peppicelli, Tyron Ward and David David Warwick-Brown attended Hendy Recycling facility at Tarmac Hendy Quarry on the 29/01/2019 and met with site supervisor Andrew Bevan. The visit was undertaken as a routine site inspection. Thank you for taking the time to attend the inspection and show us the activities carried out on site. There were no breaches recorded during the inspection. The weather throughout the inspection was cold and wet.

We could confirm that the waste facility is not accepting any waste: the transfer station is not accepting material and the inert landfill is not accepting new material. A bund of rubble is indeed obstructing any possibilities of accessing the landfill and the waste transfer station if used for the screening and biological treatment of the piles of contaminated waste material carried out under the deplyment permint (EPR-TP3098CL/ reference number PAN-002604) before disposal (Figure 1).
