Thank you for your Waste Recovery Plan (WRP) submitted as part of your application. At this stage, further information is required in order to complete an assessment in full of your WRP in response to two of the five questions from Regulatory Guidance Note (RGN) 13: Defining waste recovery – permanent deposit of waste on land.

Further information request as part of the assessment of your Waste Recovery Plan (WRP):

Is the minimum amount of waste being used to achieve the intended benefit?

Cross-sections have not been provided to confirm the depth of the Compost-Like-Output (CLO) that will be used as part of this application. The cross-sections referred to in the supporting planning documentation only refer to a noise attenuation bund.

Please provide cross-sections showing the depths needed for the subsoil and topsoil of CLO that you intend to use as the capping material for the bund. Your calculations need to include a conversion factor for the CLO showing how you have calculated that 20,000 tonnes of CLO will be needed. You must demonstrate that you will use the minimum amount of waste for the capping of the bund.

Will the proposal be completed to an appropriate standard?

Please provide further detail regarding the processes that you will use to ensure that the appropriate standard has been met. For example:

- i) Will you be grading stones for different sections of the capping?
- ii) How do you intend to prevent subsidence? Will you be turfing the area instead of seeding just the southern facing part of the bund to avoid subsidence?
- iii) And will you be surveying the final levels to ensure you've achieved the depths set out in your cross-sections (to be submitted)?

In addition to the above information, please could you clarify how many tests you performed on the CLO in obtaining your results? And when did you complete the tests?

Reason: CLO is susceptible to seasonal changes in waste inputs which then has an impact on the quality of the CLO waste produced.
