4. Details of our assessment

This report details the site visit made on the 11 February 2022 to Fred Lloyd & Sons, Permit number EPR-UP3495FT.

Officers Alex BOWDER and Greg GARDNER attended the Fred Lloyd & Sons Site at Stricks Works, Polo Grounds Industrial Estate, New Inn, Pontypool, Torfaen, NP4 0TW, for a routine site inspection at 12:00pm where we met with Mr. Oliver HAZELL (Technically Competent Manager) and David GEORGE (Site Supervisor) for this site. The weather was dry and mild all through the site visit.

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding and annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 – Significant impact or effect on the environment/people/property
- 3 – Minor impact or effect on the environment/people/property
- 4 – A non-compliance which has no potential environmental effect

COMPLIANCE BREACHES

There are no outstanding actions or identified compliance breaches following this site visit.

GENERAL OBSERVATIONS

Fred Lloyd & Sons operate under a bespoke environmental permit. This site is used as a waste transfer station and an ELV (End-of-Life Vehicle) treatment facility with the waste being distributed to other companies / sites within the UK. The site was in operation at the time of the visit and there was no waste of any type was stored outside of the permit boundary at the time of the visit. Under this permit, EPR-UP3495FT, the site is permitted to accept a maximum of 75,000 tonnes of waste per annum.

SITE INFRASTRUCTURE

The general housekeeping on the site was in good condition with no major amounts of loose debris located on the floor (as seen in photo 1). It was also noted that the concrete impermeable flooring was generally in good condition. The site has a 3 tier interceptor drainage system which was operational at the time of the site inspection with Mr. HAZELL indicating that it is regularly maintained / emptied.

On the previous site inspection (18/08/21) it was noted that there were areas on site that had excess oil present from the removal of vehicle parts on the impermeable surface. It was evident during this site inspection that any excess liquids, such as oil, from the dismantling process were adequately managed / mitigated to prevent any environmental damage and no visible excess vehicle fluids were present.

WASTE ACTIVITIES - ELV WASTE

During the site inspection, NRW Officers were satisfied at the height stockpile of vehicle shells / ELV parts and were satisfied that stockpile sizes remained at a safe height. The ELV depollution bay was in good working order with housekeeping maintained to a good standard.

WASTE RETURN SUBMISSIONS

Fred Lloyd and Sons, Pontypool have submitted their waste return data for permit, EPR-UP3495FT, on time and in full. To date (2022), the site has received 9,154.71 tonnes of waste(s) and removed 11,224.56 tonnes of waste(s). There are no unauthorised wastes that

have been accepted on site and are within the annual permitted allowance for the amount of waste to be accepted on site (75,000 tonnes).
