This was an unannounced inspection carried out by regulating officer Steven White to follow up on non-compliances found during the previous site inspection (16/02/2017).

There were no vehicles stored outside the permitted boundary and vehicles had been moved away from the vicinity of the site oil interceptor as requested following the previous site inspection. (see photos below)

There were lots of waste tyres observed on site during the inspection, this was brought up with Steve Jackson who explained that as they had a collection scheduled in for later that week they had been stored ready for pick-up. (see photo below)

Approx. 20 cars were checked to see if they had been fully depolluted (i.e. oil, coolant, screen-wash, radiator fluid, shocks, airbags) the majority of the cars checked were fully depolluted with the exception of one (a red fiesta with engine oil still in); this was brought to the attention of site operator who began proceedings to fully depollute the vehicle whilst I was there. Removed

engines were all stored under cover.

The crushing area was checked and it was observed that there were 2 oil filters on the engines stored here, this was brought to sites attention. (see photo below)

Waste returns for the site were checked - The last returns logged on our system were from 2014, non-submission of waste returns is a breach of permit condition D1.2: *A summary of the information, including nil returns shall be submitted to the Agency, in a format required by the Agency. Summaries shall be for each financial year and shall be submitted to the Agency within one month of the end of each financial year.*
