Officer Comments

This Compliance Assessment Report is for the treatment of waste to produce soil, soil substitute and aggregate activity undertaken on site. The inspection was undertaken by Liane Bacon and accompanied by Guy Lawrence (Site owner) and Jonny Young (Environmental Consultant).

Significant changes and improvements have been made to the site since my last inspection with inclusion of a weighbridge, concrete pad and pollution prevention store. It is positive to see these developments and to see the site progress.

Environmental Management System - C2 - Management Systems - Cat 4 - Condition 1.1.1

I have now had the opportunity to review the sites Environmental Management System. In the main, the bulk of the procedures are there but, as discussed, it does require some additional site specific information.

- An up-to-date site plan is required; this doesn't need to be highly technical but it does need to represent all the main features on site and the route and final destination of the drains. Colour coding this will make it clearer.
- A site specific risk assessment - key sensitive receptors should be marked on the site plan and then an assessment made on the risk the site's operations pose to those receptors. Identifying these will enable you to mitigate risks where needed. As operations change on site, risk assessments will need to be reviewed and up-dated to reflect these changes.

Please keep a copy of the EMS in the office so that it is available on request and populate it with the required records; this system provides written evidence that you are in compliance with your permit and supports your good practice.

Quality Management System for the Manufacture of Aggregates from Inert Waste


The QP plan is very good. As with the EMS, please keep a copy of the OP Plan in the office and attached any supporting records to it.

Permit Variation

The type and scale of operations on site is changing and you have submitted a variation to your permit to allow for this expansion. NRW has taken a risk based approach and permitted you to accept road sweeping waste (only) which is outside the remit of your permit. This is a short term solution to enable you continuity of business and remains on the proviso that:

- It does not cause pollution to the environment, cause harm to human health or cause detriment to amenity.
- The activity cease if the permit variation is not issued.

You have to ensure that the permit variation is capturing all of the activities on site and is a reflection of the sites operation and infrastructure. It was noted, during the inspection, that changes have been made to the sites drainage system. Please ensure that these changes are incorporated into this permit variation.
