A site visit took place on 12<sup>th</sup> March 2018. This visit was the first following the issue of the site Permit. Present were Julie Hughes Regulating Officer, Simon Thomas TCM and Mr Maldwyn Griffith.

The site is not yet operational. A revision is required to the site planning permission to allow the operation to commence.

The main purpose of the visit was to go through the first visit check list to ensure full understanding of the permit requirements, and to allow the permit holder an opportunity ask questions to clarify any permit conditions, charges etc.

A copy of the waste returns spreadsheet would be forwarded to the site for completion at the end of the quarter.

A signed copy of the check list is attached to this CAR form.

It was originally proposed by the Operator that Mr Maldwyn Griffith was to become the Technically Competent Person. However, this has since changed, and Mr Simon Thomas has registered on to the relevant WAMITAB course. Whilst working towards the full certification Mr Thomas has sat the short (EPOC) course. A copy of the certificate has been received, thank you.
