Chris Thomas attended the site to carry out a routine inspection.

Hazardous Waste documentation was viewed for tyres, batteries and oil. Pure Clean take the fluids while Unipex Aggregate Recovery Limited of Bessamer Rd Cardiff take the waste tyres for 70p plus VAT. While checking the documentation JAB93 appears to be registered as NSS913 under the Hazardous Waste producer ref. However on my return to the office the site is registered as CAF640 – from January 2016.

Could you please clarify which Hazardous Waste code is relevant.

The site exports no waste under the Transfer Frontier Shipment of Waste regulations.

While on site I also viewed the Fire Management Plans. They had been reviewed earlier in the year and had been updated. Could you please ensure copies of the Management and Incident plans are kept at a site other than the Permitted site so that in the event of a Fire/incident copies can be made available for NRW and the FRS.

Otherwise the site was clean, tidy and secure. While the recently installed interceptors appeared to be working satisfactorily.
