The site inspection was not pre-arranged. Met Griffith Griffiths on site. He accompanied me to the active tipping area on site.

Any loads tipped by contractors are left intact until they can be bulldozed. This provided the operator with an opportunity to check the waste pile for any non-conforming waste that can be removed. If the incoming waste pile is too contaminated then the contractor will be contacted and asked to collect.

There was only one recent load tipped on the ground (see below photo). This load was mostly soil and stone. However, there were bits of plastic and wood within the pile. The operator stated he would remove these and place them in the skip. He will also inform the contractor (Lawsons) to inform them of the contaminants that shouldn't be in any deposited waste piles. The operator informed me that should a contractor persist in sending contaminated loads to the site they will be barred from depositing.



No other issues observed during the site inspection.
