This was a routine unannounced site inspection undertaken by the new regulating officer for the site, Andrew Sowerby. Met and accompanied by one of the site operators, Griffith Griffiths.

During the site inspection I was shown the area where arriving vehicles are currently asked to tip their waste. The waste piles that are tipped by the trucks can then be checked to ensure the waste is compliant before it is used as fill. It was explained that not much waste is accepted onto site in the morning and that it generally gets busier in the afternoon.

When asked about problematic wastes that weren't compliant I was informed that there had been a few instances in the past where various contractors have consistently tried to tip unacceptable waste types. When this has occurred he has banned them from site.

Under the environmental permit the total void space that the operator has applied to fill is 460,000 cubic metres. Griffith Griffiths was unsure of exact figures at the time of the inspection but believes they have filled approximately a third of the void space so far.

There were no issues observed on site at the time of the inspection.
