Routine site inspection conducted by Environment Officer Leon Williams accompanied by Operators Gwenfai Rees Griffiths and Griffith Wyn Griffiths.

The visit began with an inspection of duty of care waste transfer notes. Advice was given outlining that the waste description noted on the transfer notes must match the waste description as recorded against each waste code in the EWC catalogue. Please also ensure that all waste accepted at the site is classified accurately using the various waste codes as listed in Schedule 3 of the site's permit. During the visit the waste transfer notes inspected all contained the EWC code 170504 (soil and stones). At the deposition area of the site, wastes such as concrete, bricks, tiles and ceramics were observed. Such waste can be classified under EWC code 170107 (mixtures of concrete, bricks, tiles and ceramics) or individually as 170107 (concrete), 170102 (bricks), 170103 (tiles and ceramics). Please therefore ensure that all waste loads entering Ty Mawr Farm Landfill are inspected and then classified under the most appropriate EWC codes.

A WAMITAB continuing competency certificate was obtained for Edward Lloyd Griffiths. This certificate will expire on the 8 December 2017.

It was established on site that the company, Wyn Griffiths & Sons is registered as an Upper Tier Waste Carrier (CB/HE5482QM). This registration expires on the 7 April 2017.

The construction of the trackway leading from the site office towards the landfill has been completed since my previous inspection at the site.

All waste types observed deposited in the landfill were seen to be in compliance with the waste types permitted by the site permit. It is essential that all wastes deposited on site are deposited within the boundary as highlighted within Schedule 2 of the site permit.
