The visit was undertaken by Environment Officer Matthew Buckley-Rees, who met on site with Carl THOMPSON. The main purpose of the visit was to serve a notice under section 60 of the Environmental Permitting Regulations. The weather during the visit was mild with a slight breeze and cloudy. It had been raining in the last 24 hours.

There was no visible significant difference at the site compared to the previous visit on the 17th September 2014. There remains waste on site which is not being kept in accordance with the permit conditions, namely that waste which is not specified waste is being kept on open ground. This is scored as a CCS category 3 breaches of permit condition 2.3.1 on CAR sub-criteria C3 and C4. These scores are suspended as the operator has a post conviction plan in place. Progress against this plan will need to be reviewed in the coming months.

The recent wet weather has caused a mud issue on the site itself, some areas having a depth of mud of around 5-10cm. Due to the location of the site, and the distance to the public highway, it is unlikely that mud will be deposited from this site onto the public highway, however efforts should be made to control mud on site and reduce the chances of waste becoming contaminated.

The site diary had been completed and was up to date, including information regarding equipment failures and repairs that needed to be undertaken. Mr THOMPSON explained that during the past few weeks, there had been numerous break-ins at the site. These were currently under investigation by the Police who had been to the site the previous day. Mr THOMPSON stated that he plans to install CCTV on the site as a security precaution.
