4. Details of our assessment

2020 Annual Report topographical survey

In our meeting of 14th Dec 21 and your e-mail of same date, RML have confirmed that there are areas of the landfill for which the restoration profile is not in accordance with the existing permit (*more specifically the agreed Pre-settlement plan*). This confirmed review of the topography survey drawings against the plan as undertaken by NRW, and the inconsistency amounts to a non-compliance with the permit.

We advised you on 22nd Dec 21 that we will capture the outcome of the review in a Compliance Assessment Report (CAR) form with the appropriate score.

RML have clearly stated the intention to apply to vary the Environmental Permit to include a revised restoration profile. However, you should be mindful that there are no guarantees that an application for permit variation would be approved, and the appropriate determination process would have to be followed.

Where permit non-compliances have occurred we encourage operators to return to compliance as soon as possible.

We will look at tipping heights again as part of your 2021 report.

Important information

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment. In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
