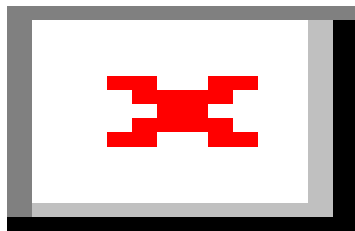

This was a unannounced routine inspection visit by the new regulating officer for the site; Paul Challender. Mike Dromgoole was present on site and escorted the officer for the duration of the visit. During the inspection the weather was overcast, wet and breezy.

In the permitted area there was a well segregated flow of waste processing from raw construction and demolition waste through to end product with all wastes being stored on an appropriately maintained surface. The vehicle turning areas in the lower part of the site require some minor attention. The end products that were available to be inspected on site were of a good quality and appeared to be appropriately graded and contained little in the way of contaminants.



The site office containing the Site Diary, Permit and Environmental Management System (EMS) and other pertinent paperwork was well ordered and accessible to all staff for reference with the notice board prominently displayed prior to entering the yard and office. The Site Diary was up to date and being utilised to record weather conditions, Technically Competent Manager (TCM) attendance etc...

TCM cover is still provided by a third party who attends site regularly on a Friday. Mike Dromgoole will be training to become the TCM in the future but there is no definitive timescale for this change.

Mr Dromgoole advised of some proposed up and coming alterations to the top end of site where the Site Office is located. As long as all required site paperwork is maintained in a readily accessible location the alterations as discussed should have not impact upon Permit Conditions.

During the last inspection some advice and guidance was provided on the submission of Waste Returns. This advice has been acted upon by the operator and third party TCM and was evident in the submitted Waste Returns for Q3 2017.

It was noted whilst on site that the yard area now extends to the watercourse at the bottom of the property and final product is stored in this area.
