This was a unannounced routine inspection visit by the new regulating officer for the site; Paul Challender. Paul Dromgoole was present on site and escorted the officer for the duration of the visit. During the inspection the weather was warm, breezy, having rained earlier in the day.

The site office containing the Site Diary, Permit and Environmental Management System (EMS) and other pertinent paperwork was well ordered and accessible to all staff for reference with the notice board prominently displayed prior to entering the yard and office. The Site Diary was up to date and being utilised to record weather conditions, Technically Competent Manager (TCM) attendance etc...

TCM cover is still provided by a third party who attends site regularly on a Friday. Mike Dromgoole will be training to become the TCM in the future but there is no definitive timescale for this change.

In the permitted area there was a well segregated flow of waste processing from raw construction and demolition waste through to end product with all wastes being stored on an appropriately maintained surface. The end products that were available to be inspected on site were of a good quality and appeared to be appropriately graded and contained little in the way of contaminants.

Some advice and guidance was provided on the submission of Waste Returns. Although Waste Returns have been submitted at regular intervals outgoing wastes have not recently been recorded on the Waste Removed tab. As your TCM submits this information to NRW please liaise with him and provide him with the correct information for outgoing wastes for all future Waste Returns.

The failure to record outgoing wastes on submitted Waste Returns is a breach of Permit Condition 4.2.2 ((G4) Reporting and notification to Natural Resources Wales) and a CCS Category 4 has been recorded in this instance.
