Chris Thomas visited the Neath Abbey Wharf SIMS site on the 8th December 2016. The site visit was conducted with Richard Morgan of SIMS.

The site was secure and overall the site appeared to be in order and generally clean and tidy.



It was noted that a considerable area of the scrap metal yard had been repaired and re-concreted. However there were areas that still need improvement. Richard Morgan stated that further concrete works were planned for January 2017. Please ensure that these works are carried out as discussed.



We also discussed the recent noise complaints which were coming from the surrounding local community. At present it is difficult to confirm which of the permitted sites in the area is definitively causing a noise nuisance however the majority of complaints appear to implicate the SIMS yard. The complaints appear to have reached the peak several weeks ago which coincided with a period of significant night-time working. I do not intend to take action or carry out any noise monitoring at this time however if the problems re occurs or persists NRW may request that SIMS carry out noise monitoring, consider noise abatement measures, or limit night time working to reduce noise pollution coming from site.
