Continuing competency has been maintained for site, expires 08/02/2020. In line with condition 1.1.1 (b) of the permit.

Infrastructure

Concrete pads were in good condition during the inspection. Continue undertaking routine maintenance and undertake remedial works where required.

No issues were identified with site security during the inspection.

Waste Storage

During the inspection, all wastes were stored on impermeable surfaces with sealed drainage supported by two interceptors. In accordance with permit condition. During the inspection no non-permitted waste types were identified.

Used gas cylinders were stored in a locked and labelled cage near the entrance to the site.

Batteries are stored within the ELV shed in suitable containers.

Action - Please forward me the transfer notes for the ELV's that were received from Ammanford Metals.

Waste Tyres

Waste tyres were stored in a skip near the ELV garage, as discussed on site the skips are removed and replaced when full. This keeps the total amount of intact waste tyres under the 50 tonne limit set under schedule 1 of the permit.
