4. Details of our assessment

Compliance assessment undertaken to in response to incident reports between 9th-19th February 2021, WIRS references: 2101186, 2101298, 2101443, 2101498. The incidents relate to discharges from Ynys Bridge CSO linked to the capital works between Ynys Bridge and Tongwynlais to duplicate and upgrade the Ystradyfodwg and Pontypridd (Y&P)

Trunk Sewer.

The discharges was due in part to flow restrictions in the sewer to enable the connection of the new sewer. We recognise that working practices and management of the situation was reviewed and improved following the initial incident. However, the discharges were outside of the provisions of the permit for the discharge of storm sewage and therefore constitute permit non-compliance.

This has been categorised as a C3 non-compliance following assessments made at the time of the incidents, a formal warning has been included as part of the compliance assessment report in line with our enforcement policy.
