This was an unannounced routine compliance visit carried out by Malcolm Dines and Jeremy Goddard who met with John Adams (Director and site TCM). The weather was

sunny and dry and the site was operating.

Other general observations/comments

During his compliance visit we discussed site operations and the overlap between your waste and installation permit including the quantity of inert waste accepted into the site and what it is being used for. You stated that the inert waste is used for daily cover on the landfill site. You must ensure that both your Environmental Management System (EMS) and your reporting of waste returns, reflects this accurately and that you do not accept or store more inert wastes than your permit allows. Please consider whether you need to revise your EMS to ensure the current permit restrictions are complied with, or vary your permit to increase the tonnage limits for waste acceptance and storage, especially of inert wastes.

New sorting equipment has been purchased and was in the process of being installed in the waste reception bay.

Your Fire Prevention and Mitigation Plan and Environmental Management System will be reviewed as part of our 2022 compliance work for the site
