4. Details of our assessment

Site Inspection

The permit states that sample points must be clearly labelled with Storm Sample Point and

the specific number at ST16176957. This wasn't seen during the inspection; when the performance manager was asked about this, they were also unsure. Therefore, we request a clearly labelled sample point at this location is established with photos once completed. If this location does exist and is already labelled, please can proof be provided in the form of photographic evidence.

Storm tanks were empty during inspection, with no evidence of litter present. It was clear that they have not been used in a long time and appear to be well maintained.

On review of the site diary there was no evidence of recent storming activity being recorded.

UV was not operational at the time of visit due to not storming and being out of the bathing water season.

Actions:

1. Provide a photo of the existing Storm Sample location
2. Provide a photo of clear labelling of said sample point
3. Send confirmation NGR to Officer Charlotte Rhodes
