4. Details of our assessment

Biomass UK No.2 Ltd

Permit number EPR/AB3790ZB

NRW has received the Annual reports for 2021. During 2021 the site has had to deal with continuing planning related issues and the ongoing Covid-19 situation. Consequently, the operators decided to take the plant fully offline to facilitate a series of plant mechanical improvements. With the exception of a number of commissioning runs the facility has been largely non-operational during 2021 and will come online once clarity around the planning regularisation is assured by the Welsh Government. As a result of the above, the site processed less than 1000 tonnes of wood chippings during 2021. All fuel storage and reception areas have since been emptied.

The annual performance data detailed in form 'Performance1' reflects this lengthy shut down period. In 2020 Biomass UK co-incinerated 25,431 tonnes of wood compared to 813 tonnes in 2021. Given the limited number of operations and the very low use of raw materials and energy, no real comparison can be made with the previous year's performance.

Emissions to Air (periodically monitored):

QAL-2 Periodic monitoring and AST testing was not undertaken in 2021 as plant was largely non-operational. The plant has been in shutdown all year, except for a short commissioning run in Quarter 3 2021, upon re-commencement of operations QAL-2 periodic monitoring will be undertaken at the earliest opportunity.

Reporting of Residue Quality:

Residue testing has not been carried out in 2021. The plant was sporadically operational only in Q3 2021 and did not produce sufficient residue to justify testing.

Emissions to Air (continuously monitored):

CEMS equipment has been in calibration and operational since December 2019. Plant has been in shutdown for majority of 2021. All data therefore relates only to a short period during August and September 2021. The emissions to air have been sent to NRW every quarter due to the requirement of their permit. Therefore, they have previously been assessed and acknowledged in CAR Form CAR_NRW0038887. All readings were within permit limits.

Q4 Air emission were received and were blank to reflect the current shut down of the plant.

Site Improvements:

The site has been subject to a number of plant engineering reliability modifications with the intention of resolving a number of reliability issues. The impact on efficiency will only be known once the plant is back on line and operational.

Q1, Q2, Q3 and Q4 reports were sent on time and are summarised as follows;
