This is a review of the 2021 annual returns data to satisfy reporting conditions of Permit JP3536LS. The operator submitted 2021 annual returns data to NRW on 10.02.22. This date is after the reporting deadlines specified in the permit and NRW considers this a breach of permit condition 4.2.1 (G4-CCS4).

Action 1: Ensure annual returns data for 2022 are submitted by the reporting deadlines specified in the permit.
