Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

## 4. Details of our assessment

This is a review of the 2021 monitoring and annual returns data to satisfy reporting conditions of Permit BX4666IZ. This data was received by NRW 09.02.21 and was therefore within the reporting deadlines specified by the permit.

With reference to form A1, emissions monitoring data was provided for the following emission points: A2, A5, A7, A10, A11. All emission points were below specified ELVs for particulates (1mg/m<sup>3</sup>) and Volatile Organic Chemicals (VOCs) (75 mg/m<sup>3</sup>). Specified metals and white spirit were also monitored as per permit requirements but no ELVs are set for these parameters.

With reference to form S1, quarterly monitoring data, Chemical Oxygen Demand (COD), was provided for emissions to sewer. These results were below the specified ELV of 500 mg/l.

With reference to form E1, total energy use increased in 2021 (14,931 MWh) compared with 2020's reported figures (2,109 MWh).

With reference to form WU1, total water usage decreased in 2021 (228m<sup>3</sup>/yr) compared with 2020's reported figures (342 m<sup>3</sup>/yr).

With reference to form R1, waste disposal increased in 2021 (80.87 tonnes) compared to 2020 (44.97 tonnes).

Permit condition 4.1.2 requires the following performance parameters (specified in Table S4.1) to be recorded and reported to NRW every 12 months: fugitive emissions (percentage of solvent input), organic solvent consumption (tonnes/year). This data has not been provided to NRW as part of the annual returns submission. NRW considers this a breach of permit condition 4.1.2 (G4-CCS4).
