4. Details of our assessment

On 18 October 2021 you were issued with a Compliance Assessment Report CAR_NRW038841 which stipulated an updated Pest Management Plan must be submitted by 31 January 2022.

No Pest Management Plan was submitted by the close of 31 January 2022.

C2 – General Management – Management system and operating procedures – Permit condition 3.1.2 – CAT 2 breach

You have been scored a breach against permit condition 3.1.2 (a) as you do not have the required emissions management plan, specifically a Pest Management Plan, in place to minimise the risks of your operations on the local population and environment.

3.1.2 The operator shall: (a) if notified by Natural Resources Wales that the activities are giving rise to pollution, submit to Natural Resources Wales for approval within the period specified, an emissions management plan.

On 11 February Sally Wakeford received a response to the query of why this documentation had not been provided, and it was stated that you would have all the relevant information by the end of the month (end of February).

ACTION: you must provide an emissions management plan, namely a pest management plan, which reflects the operations on site and minimises the pollution to the local environment. You must have consideration for the appropriate measures laid out in Environment Agency Guidance “Fly Management: How to Comply with your environmental permit.” By 04 March 2022.

Failure to provide documented comprehensive measures as to how you will manage your site for pests could result in other enforcement action such as suspension of the permit.

NRW will consider if further enforcement action is required to ensure this deadline is met.
