4. Details of our assessment

Annual performance reporting

Condition 4.1.3 of the permit requires a report on the performance of the permitted activities over the previous year. The 2021 annual report was received on the 01 February 2021.

Review of monitoring returns

Water usage - water usage remains similar to 2020 despite reduced production, COVID and Avian influenza.

Emissions to sewer - emissions to sewer are monitored for Mercury, Chemical Oxygen Demand and average flow. No Mercury was detected in the emissions to sewer and readings are below the emission limit value (Condition 2.2.2.8) and annual mass release limit (Condition 2.2.2.10). COD readings were taken in accordance with Condition 2.10.2, the readings remain consistent with previous years. Effluent flow was also monitored and remains similar to 2020.

Energy Usage - energy usage remains similar to 2020.

Waste - waste disposal and recovery remains similar to 2020.

Refrigerant Use - refrigerant consumption has decreased slightly with Q3 being significantly higher than the other quarters.

EMS Summary Report

An EMS summary report was submitted in accordance with condition 4.1.5 on 01 February 2022.

There are no non compliances in respect to the above, and the site is compliant with the permit requirements.

Schedule Notifications

A Schedule 1 Notification of abnormal emissions was submitted in accordance with condition 5.1.1 on 27 October 2021. Following a release of refrigerant gas in roof void on 26 October 2021, approximately 550kg of R407f was released. The evaporator and pipework were isolated. A full invasive F gas leak check was carried out to confirm no further leaks. **This has been scored a CCS3 breach of Condition 2.2.1.2. unauthorised emission.**

Action 1: Undertake investigation into root cause analysis of leak and report back to NRW by 31.03.2022.

Action 2: Please ensure notifications detail the length of time of release and more details regarding the likely cause and remedial actions to avoid further occurrences. This should be implemented immediately.
