4. Details of our assessment

Angharad Clark and Michael Edwards made an unannounced visit to the Trostre depot of CWM Environmental Ltd on 4th February 2022.

The weigh bridge operator stated that there was no manager on site but that he could contact one if necessary. He was unaware of the location of the site permit.

The site was clean and orderly with good separation of waste streams.

However, there were waste batteries stored on a table with some spilt liquid present.



Table 1.1 of your permit states that *Batteries shall be stored in accordance with section 4.8 of the working plan within leak proof container(s) fitted with close fitted lid(s) to prevent ingress of surface water.*

Please ensure batteries are stored in line with permit conditions.
