4. Details of our assessment

This Compliance Assessment Report (CAR) is in response to NRW being informed by the operator of an unpermitted emission point to air at the installation. On 21 October 2021, the operator raised the absence from the revised permit of an emission point for the grinding process at the plant.

A review of the documents relating to the initial permit application and subsequent variations has been undertaken by NRW. An emission point for the grinding process has not been included in previous versions of the permit, and no information has been supplied to NRW relating to the operation or emissions from the grinding process within the installation.

The decision document for the first issue of the permit (A001) dated 5 July 2010 included reference to the following:

"milling process blends, grinds, mixes and extrudes . . ."

The same document identifies only three process emissions to air in table 2.2.1:

A1 Cooler Unit - in current permit

A2 Cooler Unit - in current permit

A3 Boiler Stack - removed from current permit

A further variation to the permit added emission point A4 (Bulk Intake Extraction Unit) which was removed during a subsequent variation.

Since the issue of the initial EPR permit and subsequent variations, the operator has not raised the absence of the grinding process emission point from the permit and has operated the emission point throughout this period.

Permit condition 3.1.1 states that there shall be no point source emissions to air except those listed in schedule 3 of the permit. This breach has been scored as a CCS 3 breach under sub-criterion E1 emissions - air.
