4. Details of our assessment

This was a pre-arranged inspection of the site as the site is no longer operational. We were met on site by Sue Parry, Operations Centre Manager, Haydock who was previously the Operations Manager and TCM for the Buckley site.

The site stopped accepting waste on 12th November 2021 and all waste and equipment was removed in December 2021.

This inspection was to check the condition of the site as PHS have applied for a permit surrender.

The site had been cleared of all waste and associated equipment. The site was secure and all areas of the site appeared in good condition.

The inside of the unit has been deep cleaned and appeared in good condition.

The site is permitted as a clinical waste transfer station. The activities on site, since the permit was granted, was to temporarily store waste or treat waste prior to eventual removal from site. The waste treatments on site only involved repackaging or compacting the waste. No other waste treatment has occurred on this site.

The site history has been reviewed and there have been no pollution incidents recorded. The site has always had a management plan in place to ensure any risks to the environment were minimised.

I therefore recommend the site for a low risk permit surrender.
