The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment against IQE (Europe) Limited (hereafter IQE) monitoring returns for June to December 2021 and review the annual reports.

NRW received the following from IQE:

For 2021 the sites energy usage has increase, the CO2 per unit has also increased to 0.0071g

- **Form W1**

The total water used at the site has decrease by 6.4% from last year to 2441m³.

- **Form R1**

The waste per unit has decreased to 0.0008g from 0.0009g in 2020. The site produced 235.70tonnes of hazardous wastes and 12.91 tonnes of Non-Haz waste.
