Site confirmed there were no incidents or accidents at site during 2021. The flare stack is required to be monitored if the usage is >10% of the time. This was not required for 2021 as the flare stack was used 296 hours out of 8471 operational hours for the landfill gas engines ~3.5%. Annual reports accepted without further comment.
