The purpose of the inspection was to determine compliance with the Regulation 36 Notice which expired on the 26 July 2017.

Adrian Stewart was on site.

The area adjacent to the main building had been freshly concreted . ELV's that have not been treated will be stored in this area.

The depollution bay has been repaired and any spillage in this area will be contained within the bay.

The old brick tank used to collect contaminated surface water has been removed and replaced by a concrete structure that will require emptying on a regular basis and the contents tankered away and disposed of at a site authorised to accept hazardous waste.

There has been fresh concrete laid south west of the site that is being used to store scrap metal. This is also has a concrete structure for the collection of contaminated surface water and must be emptied regularly.

You have confirmed that both these concrete structures comply with the requirements of a sealed drainage system. We will be looking at the hazardous waste consignment notes for the disposal of effluent from these structures during our next inspection

A T9 exemption has been registered for the site.

An Environmental management system and staff training will be completed by 1 October 2017.

If you produce or store more than 500kg of hazardous waste in a year you must register your premises as a hazardous waste producer. the Registration lasts 12 months. you can register on line using the link below.
