There has been prolonged hot and dry weather.

I am please to see the investment and site improvements that have been made to the site.

A new ELV depollution bay has been constructed to the north of the site. This has been fully equipped with depollution equipment. We were shown the depollution of a vehicle by Mal, a new employee who has experience and training in depolluting end of life vehicles.



Other employees are being trained to use the depollution equipment and some are also undergoing WAMITAB courses.

Intermediate Bulk Containers are being used to store diesel and petrol from the depollution process. These are being stored in the old depollution bay. These containers are provided with secondary containment as they are stored on spill pallets, within an undercover bunded area. Currently the IBC's are labelled on the adjacent wall. Labelling the IBC is recommended.



The permanent storage location for depollution fluids is yet to be decided. Careful consideration needs to be given for all depollution fluids for the safe handling, storage and decanting areas.

The EMS should be updated to provide a safe system of work for the depollution process and the maintenance and inspection of all equipment. It should also include the training requirements and list who is suitably trained.

A gutter has been installed on the T9 building and the new depollution bay. Careful consideration should be made where this drains to as it is clean water and can be released to soakaway or surface waters.
