The site inspection was not pre-arranged. I was accompanied by Team Leader Caroline Moscrop onto site.

There was improvement works being undertaken on site to replace a section of damaged concrete and improve some of the drainage. As a result part of the site had been dug up and sectioned off. The new concrete is due on Saturday.

During the visit it was observed that Nortons were on site collecting waste batteries. As Nortons require the lids of the battery boxes to be removed to help stack them on the lorry none of the battery boxes had lids at the time of the site inspection.

It was noticed that some of the battery boxes on site had holes in the side. When this was pointed out we were informed that the boxes that are received from companies such as Nortons are often delivered to site damaged. As the permit states that batteries should be stored in designated covered and bunded containers we would expect to see these containers sealed. Should we notice damaged battery boxes being used to store batteries in the future we may have to consider applying a CCS breach. You should therefore try to ensure that only undamaged battery boxes are used to store waste batteries.

Overall, there were no issues observed on site and everything seemed to be tidy and well ordered. If you have any questions regarding any of the above comments please contact me.
