A routine site visit took place on Friday, 25th November, 2016. Weather at the time of the visit was dry and sunny. The regulating officer Julie Hughes as accompanied by the Operator Mr J M Hughes.

Monitoring – Permit condition table 3.1 states that a temperature probe be available to monitor the temperature of the compost. Although a temperature probe is not available on site, there is a mechanism in place to monitor the temperature of the composting rows. Mr Hughes gave a demonstration as to how the hand held equipment worked. Temperatures recorded will be kept in the site diary.

Compost Like Output (CLO) – is still being stockpiled on site. A new outlet will need to be sources as this material can't be applied to agricultural land. The deployment for the original site sourced for the CLO has expired.

Waste transfer notes received from Anglesey Council and notes issued from site were checked these complied with duty of care. Season tickets are issued for compost leaving the site.

Compost produced on site does not achieve PAS100 accreditation is therefore still considered to be waste. Compost produced on site is spread on the farm under deployments registered under Silverwood's permit.

The Operator is working on completing his WAMITAB certification. In the meantime the role of Technically Competent Person is covered by Julia Silverwood. However, the Operator has approached a local person, who is WAMITAB qualified, to take on the role. NRW will be notified if these changes takes place.

Site diary was checked. The diary contained information relating to the activities on site including field numbers where compost had been spread.

A request was made by the Operator for a copy of his waste carriers' registration. Copy of letter enclosed.

The Operator is also considering applying for PAS 100 accreditation in the near future. Contact details for the relevant organisations which deal with quality protocols are as follows:
