As part of this inspection I met with site Manager Phil Jordan and discussed options for surrender of the waste permit. The company do not use the permit to its full potential and from what was explained the operations on site do not require a waste permit. The operation could benefit from waste exemptions such as: the Non Waste Framework Directive 3 ('temporary storage of waste at a place controlled by the producer') exemption and a S2 waste storage exemption. Information on both of these exemptions was given to Phil Jordan on site.

Further guidance on permit surrender will be sent out separately.

The site was well organised and no permit non-compliances were observed.
