Natural Resources Wales receiving two incident reports relating to noise coming from the Window Plastic Recycling site on 28 September 2015. The incident was attending on 29 September 2015 at 0800. At 0800 it was substantiated that noise coming from Fenestration Recycling Company Limited was causing a Category 3 incident off site.

The reason for the noise is that metal from the window frames that have been processed through the new hammer mill is hitting the hopper.

There is no condition within the Environmental Permit reference EPR/HB3938RN held by Fenestration Recycling Company Limited that relates to noise. The treatment of plastic window frames by a hammer mill is a waste management option that is not permitted in Table 1.1, section a)i).

Subsequently, the use of a hammer mill for treatment of plastic window frames is a breach of Condition 1.1.1a) and Table 1.1a)i). This has been scored a C3 under F2 Amenity - Noise. This could also have been scored under A1 Permitted activities - specified by permit, but has only scored under the Noise section of the Compliance Assessment Report.

Following attendance at the incident, Stephen Hemming confirmed that initial improvements to the sound insulation of the hopper and the construction of a temporary building are due to be completed by 5 October 2015.
