EPR/PP3294FJ - Ffridd Rasus Landfill (Area2) and Civic Amenity Site

Pre-arranged site inspection carried out by Environment Officer Rhys Thomas. Accompanied on site by Steven Edwards and Susan Francis of Gwynedd Council. Main purpose of visit was for site Regulatory officer to familiarise himself with operations on site.

Discussions took place during the visit regarding current and future operations on site and the arrangements in place with the permits at the Civic Amenity Site, Transfer Station building and In Vessel Composting Facility. Operations at this part of site are currently covered by three separate permits. The In Vessel Composting facility has not been operational for several years and this permit as it stands is no longer required. The operator wishes to utilize the IVC building and associated outdoor storage areas for other storage and waste transfer purposes. Extending the boundary of the Civic Amenity site/ Area 2 Permit was one of the possible options discussed. Guidance will be sought from the NRW permitting team and further advice will be provided with regards to the options available for these three permits in due course.

During the visit the Civic Amenity site was inspected. The area was fairly quiet at time of inspection. All wastes were appropriately stored in skips and containers and the site was tidy and organised. Activities on site were not giving rise to any amenity issues at the time. No other parts of the permit were inspected during the visit.
