Comments:

Upon arrival at the site I was met by Normunds Slajevs and I explained that I would be carrying out a site inspection. Mr Slajevs explained that Barrie Cotterell (TCM) had been on site earlier in the day and had only recently left the site.

During the site inspection the following was observed;

- ☐ The site was not operational during my inspection
- ☐ Mr Slajevs was the only person present on site
- ☐ The site appeared to be within the permitted tonnage limit of 100 Tonnes (Photo 1)
- ☐ The plastic product was spread throughout the yard area (Photo 2). The introduction of concrete bays would ensure that plastic does not overspill over the impermeable section of the yard or overspill outside the site boundary (Photo 3).

3.2.1 – Site security – The perimeter fence which acts as the site security was in a particularly poor condition (Photos 4 & 5). The fence along the north section of the site was also in a very poor condition (Photo 6). It is suspected that the damage to the fencing is as a result of product being stored in such close proximity to the perimeter fence; this also results in product over spilling from the site boundary. There is a considerable increased risk of unauthorised access to the site as a result of the damaged site security fencing.

This is a breach of the permit which states;

Site Security - 3.2.1

Site security systems shall be provided at all times during the subsistence of this license, the objective of which shall be to prevent access by humans and livestock which is not authorised either by the License Holder or under legal powers of entry. These shall be installed, operated and maintained, and shall be fully documented and recorded, in accordance with section WP/3.001 and WP/3.200 of the working plan. This has been recorded as a CCS 3
