Routine site inspection carried out by Environment Officer Rhys Thomas. Accompanied on site by TCM Lee Jones. Purpose of visit was to check compliance with permit breaches identified during the last site inspection carried out on 10/06/2016.

During the inspection it was evident that efforts had been made to reduce the amount of waste stored on site and site was considerably tidier and more organised. The amount of waste wood stockpiled on site had been reduced and was all contained within the designated storage bay. Area between bay wall and fence had also been cleared of all loose waste. There remains a large amount of plasterboard stockpiled on site however efforts had been made to keep the plasterboard separate from the inert waste stockpiled next to it.

Skips containing mixed wastes along with the stockpile of trommel fines have been removed from the exempt area and these are now appropriately stored within the permit boundary. Some temporary fencing has been erected along the permit boundary and exempt area. Please ensure that this boundary remains in place to provide a clear distinction between both areas of site.

During the inspection a discussion took place regarding the new waste return form. Some issues have arisen with the electronic forms submitted by the operator. This issue now appears to be resolved. Please ensure that all outstanding waste returns are submitted to Natural Resources Wales by 19/08/2016.

It was good to see that efforts have been made to bring the site into compliance. Please ensure that work continues to keep in compliance and that all wastes are appropriately stored within bays and containers at all times. Please also ensure that you are familiar with the conditions of the waste exemptions registered for the exempt area of site to ensure that operations are compliant.
