4. Details of our assessment

Liz Park arrived on Station Road, Rhayader to undertake an unannounced Odour assessment as odour incident reports are still being received.

The following non-compliance has been identified.

F1 - Amenity - Odour - Permit Condition 3.3.1 - CCS Cat 3

An authorised officer from Natural Resources Wales has substantiated an odour emission outside the permit boundary at a level to cause a loss of amenity. It is not considered that all appropriate measures to prevent, or where that is not practicable, to minimise the odour have been undertaken.

Immediately upon leaving the car an odour of mixed waste was noticed. Whilst it was intermittent due to a breeze from the direction of the transfer station, it was at a level to cause a loss of amenity. It would not be pleasant for people in the vicinity to enjoy outside space. However, due to the short duration of the assessment (officer only had as short time available due to other commitments) it is not possible to say how long this would have lasted for.

It was not possible to make an assessment inside a building on this occasion.

It was noted at the time of the assessment that the doors to the transfer building were closed.

Powys County Council were immediately notified of the odour. An assessment by Nigel Hicks at 13:15 reported a slight smell of a mixture of residual waste and silage at a location approximately 60 m further away. Liz Park confirms that she only smelt general residual waste.

The Appendix 3 - Odour Complaint Form records that a possible cause is from the extraction fans.

It is considered that this may be a possible source as there is no end of pipe abatement or dispersion to the exhaust from the extraction fans.

ACTION: Assess the potential sources of the odour, in particular the potential source from the extraction fans, and implement appropriate measures to manage the odour emission. Please refer to the H4 Odour Management Guidance. Section 4 contains details on control measures which you may wish to consider.
