11th July 2017, a site inspection was conducted at Heol Ty Gwyn by Ffion Thomas and accompanied by Laura Phillips.

Meeting was held with Mark Kirk, Keir Contract Manager and Adam Neill Area Supervisor to discuss Sally's previous actions had been dealt with.

Mark Kirk to provide a copy of site layout. To confirm procedural changes to layout that confirm no waste stored off the sealed system (justification for not undertaking engineering works to connect to foul).

Confirm cross referencing/review of agreed site action plan.

Above actions have a 1 week timeframe, unless otherwise agreed in writing.

Site Inspection

No none-compliances seen.

The site was found to be in very good management, suggested ensuring surface water drains are cleaned regularly as a very small amount of debris was seen within the gully pot.

Exemplar induction undertaken on site, recommended rolling out to other sites. A discussion was had regarding inert skip rejection by disposal site – suggested that this is discussed with the customer and they fully understand the percentage allowable contamination.

There was no windblown litter outside the gates.

A discussion was had on what measures are in place with the changeover of skips. This is being managed with an empty space at the site where they can put full skips on the sealed drainage area when changing.
