Officers PERRY and WARWICK-BROWN attended site on 20/11/18 to conduct a site inspection following initial visit earlier in the year. Officers were Daniel Lewis, Director of Mekatek, who informed us of fire drills and emergency procedures before commencing inspection.

Officers were given a full brief of PPE requirements, and were then escorted around the whole facility, going through each process from import to export, and no non compliances were found on date of inspection.

The ongoing issue of attempted break ins to the site was discussed, relating to the copper that is currently stored on site as a product of the processing, however Mr Lewis was confident in new security measures that have been implemented will negate much of this risk.

As previously mentioned, there are no compliance issues to report, and another inspection will be scheduled in due course.
