As Lee was the only person on site (due to health and safety concerns) there was no crushing, grading or sorting going on at the time of the visit

Dust suppression measures were checked, as there was no operations going on site during the inspection there was no dust being produced.

Site diary was checked, there were no issues. COTC for the site (Lee) was on site for more than the required amount of time a week.

A number of waste transfer notes were checked, the majority of which were fine but one had the EWC code and SIC code for the waste missing, this was brought to Lee's attention and measures were put in place to ensure it didn't reoccur.

Waste Returns checked, there were no issues found.
