Monthly monitoring data

2018 monitoring data (Groundwater, Leachate, Surfacewater and Landfill gas) received and reviewed.

We have previously discussed maintaining access to, and locating the In-waste leachate level monitoring points (with replacing / reinstating those that are lost / damaged) so that potential issues can be identified at an early stage. The field data in Appendix 4 of Annual Report below details that 6/10 are UTL. On-going work. Considered non compliance CCS 3.

AER (condition 55 of permit)

2018 Report received and reviewed, including Trace gas, flare and engines monitoring data.

Conclusions and planned further improvements in Section 9 noted.

In relation to a potential reed bed treatment system, leachate quality monitoring values noted, including those in perimeter leachate monitoring boreholes (e.g. ammoniacal nitrogen range 20-200mg/l) Sewer / River discharge flows (as recorded over 24hr period) in Appendix 6 also noted.

At present, we acknowledge that it may be difficult to fully treat the leachate using reedbeds without some form of pre-treatment. We have previously discussed how a reed bed system could be used in part as a 'polishing' mechanism, or, whether some of the clean inputs can be removed. NRW would welcome draft proposals.

No complaints received during the reporting period.

Separately, CCBC are continuing to work though the actions in our last CAR (ID NRW0033954)
