Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation adds a decanning treatment of catalytic converters activity to the existing Tier 3 bespoke permit. The treatment activity results in producing metal casing which has refractory ceramic fibre (RCF) matting remaining within. Due to the waste potentially containing RCF matting this waste is classified as hazardous waste and given a waste code of 16 02 21*.

There will be no treatment of catalytic converters apart from the decanning process.

In addition, the varied and consolidated permit includes an improvement condition for the operator to submit a fire prevention and mitigation plan (condition 2.5, Schedule 1, Table S1.3). As per the operator's request, the permit has been updated to modern conditions.

No other changes are made to the permit.

The schedules specify the changes made to the permit.
