Compliance Assessment Report – Ty'r Eos Farm (EPR-ZP3799FM, EAWML 30049)

A desk-based audit of the Ty'r Eos Farm Closed Landfill (EPR-ZP3799FM, EAWML 30049) has been carried out by Officer David WARWICK-BROWN as part of NRW's Closed Landfill project, meeting our requirement to undertake periodic site inspections and audits of regulated facilities. The historical records of this site have been reviewed for environmental monitoring and the following outcomes have been determined.

(G1) Monitoring of emissions and the environment: Permit condition 43– Category 3 breach

The assessment of this permit has determined that there is no requirement for monitoring beyond stability monitoring, which has been confirmed within the closure plan (dated 07/04/06). This plan states that the 'slope stability and any settlement will be monitored by the use of 6 number stations as shown on drawing reference No 3'. It has been noted from previous compliance visits that the stability of the site is the main concern due to the steep banks, but no evidence of this monitoring has been found on NRW's database.

The permit variation, submitted on 03/01/07, stated that 'the site shall, subject to the conditions of this licence, be operated using the techniques and in the manner described in the closure plan submitted on 7th April 2006, unless otherwise agreed by the Agency in writing'.

Since no evidence of the stability monitoring for this site has been found, a **category 3 breach** is being scored for this non-compliance with both the closure plan and the permit variation.

Action:

Please submit any evidence of stability monitoring that may have taken place following the submission of the closure plan. If no evidence of this monitoring can be found, then please undertake an environmental monitoring regime for the slope stability of this site to meet the requirements within the closure plan and the permit variation.

Otherwise, the site has been compliant within the conditions of the permit and there have been no further reported issues resulting from this audit.
