INTENTION TO INVOICE

On 22 December 2015 Natural Resources Wales attended an incident at Heol Ty Gwyn Civic Amenity Site, Heol Ty Gwyn, Bridgend, CF34 0BQ because of actual or potential pollution of water.

The law allows us to recover the cost of investigating and dealing with these incidents from the person(s) responsible. This is known as the 'Polluter Pays' principle. Natural Resources Wales can still recover costs when an incident does not result in pollution of water and when an offence has not been committed.

More information on pollution incident cost recovery can be found on the Environment Agency's website by searching under "Pollution Incident Cost Recovery". It is our intention at a future date to have this information available from Natural Resources Wales website.

Our officers are able to offer free pollution prevention advice and assistance but we must also consider recovery of our costs when responding to incidents.

I can confirm we will be sending you an invoice. If we believe that an offence was committed in relation to the incident, this will be dealt with separately.
