4. Details of our assessment

This was a pre-arranged inspection primarily as a site handover of regulation of the Environmental Permitting Regulations (EPR) permit from Natural Resources Wales (NRW) officer Ian Oakes to NRW officer Paul Challender. Dr David Poole an NRW officer, also attended to gain an understanding of the site's processes and layout. Going forward Paul Challender will be the lead officer for the aspects of the site pertaining to the EPR installations permit and Ian Oakes will retain his position for regulating the COMAH aspects of the site.

Available staff from Sherwin-Williams were the EHS Manager, EMEAI Regional Platform Engineer Resin and Neil Booth. The Site Manager gave all three NRW officers a full site tour explaining the site layout, recent alterations, bunding, drainage, safety systems and processes, control room and plant. Proposed developments and the submitted permit variation were also discussed.

No issues were identified during the inspection and therefore no scores applied.
