4. Details of our assessment

This Compliance Assessment Report follows a review of routine quarterly emissions monitoring returns during the period 1st October - 31st December 2021. It also covers a review of annual reports for 2021.

All reports received on time.

a) Emissions to Air

Emission points A1 - A4 all emissions compliant with the permitted limits throughout the period.

Emission point A12 - annual extractive emissions monitoring completed 21 - 22 July 2021 - compliant.

Emission point A11 - no CEMS data presented following the mothballing of the Gas Treatment Plant nitrogen rejection unit 24/06/20 (Nil return).

Emission points A10A - A10E, annual extractive NOx and CO monitoring completed on all 5 auxiliary boilers. No emission limit values apply.

b) Emissions to Water

Emission points W1, W2 & W3 - all parameters within permitted limits.

c) Other Reports

- Annual Reporting Forms supplied as required, including AR1 & HR1.
- CEMs Invalidation logs received as required. The number of invalid days did not exceed 10 days for any single LCP in 2021.
- 2021 End of Year Review received, 100% ELV compliance achieved during 2020, no notifiable incidents or non compliance recorded. Annual production data supplied as required.

d) Improvement Condition 28

Further to your letter as received 05/01/22, NRW accepts that the requirements of Improvement Condition 28 are no longer relevant following the de commissioning of the Thermal Oxidiser (Emission Point A11).

If the Thermal Oxidiser is to be returned to service then NRW shall be notified and the requirements of this Improvement Condition will be re-applied with a revised time table for completion.
