The site was inspected on 26 June 2018 by Sally Wakeford, accompanied by David Warwick-Brown from our permitting department.

The site is non-operational and no one was present on the site at the time of the inspection.

The gates were secure, and no waste operations were taking place, however large amounts of waste remain on site.

Please be aware of the length of time waste can be stored on site - in line with the Landfill (England and Wales) Regulations 2002, waste should not be stored for longer than 3 years. This was raised for your attention in November 2017 during an inspection documented on CAR\_NRW0032533. All remaining waste should be cleared from the site by November 2020 or it will be deemed an illegal deposit of waste.

### **ACTION: Confirm the amount of waste soil and stone remaining on site by 31 August 2018**

Following your permit variation in March 2017, Table S1.3 require the operator to submit a written Environment Management System to Natural Resources Wales for approval within 3 months of permit issue (June 2017.) or otherwise agreed in writing. To date we have not received a submission for this, however the site is non-operational at present.

**If and when activities begin again, you must submit an updated EMS produced in line with the standards set out in Technical Guidance Document: 'How to comply with your environmental permit'.**

**Any compliance criteria not highlighted in the above summary should be considered as not assessed.**
